

HOW TO: Request a Lock Extension

If an extension is needed on your already locked loan, you may request that under the Product Pricing and Lock Tab. (The extension can only be requested prior to the loan expiring. If it does expire before you are able to request please contact Secondary Markets.)

Step 1: Click on Change Request
